Despite challenges such as limited industry access, the institution has effectively addressed them through strategic partnerships and alumni engagement.
- **2.** AIT has facilitated 456 project-based internships and attracted over 90 companies offering "dream" and "super-dream" job opportunities. The institution also hosted 18 expert lectures, 40+ workshops, incubated 8 startups, and earned national recognition through prestigious scholarships from Google, Reliance Foundation, and Deutsche Bank.
- **3.** AIT affirms that its well-documented and sustained practices align with NAAC's focus on quality enhancement and innovation, producing measurable, transformational outcomes for students and the academic community, supported by verified and uploaded documentary evidence
