

**MINUTES OF INTERACTION OF JOINT DIRECTOR  
WITH STUDENTS ON 28 JAN 2022**

1. An online meeting was held at 1600 hrs on 28 Jan 2022 to discuss about non-payment of hostel fee by students. The meeting was headed by Joint Director, AIT, coordinated by President Student Council and 171 students from all years except FE.
2. The discussion points are given in succeeding paras.
3. Rooms in H Flank are allotted to BE students. But as per query raised by some students their rooms were occupied by some other students. How to pay the fee?

Decision Taken.

Rooms in H Flank are meant for BE students only. Whether it was allotted to any other students, will be confirmed with Warden, BE. The student has to pay full hostel fee minus amount paid by occupied student temporarily, if any.

4. Why hostel charges to be paid by students if they have been attending classes online from home?

Decision Taken.

Rooms were allotted to students based on their merit and submission of request form. The allotment list was uploaded on website for info of students after allotment. Hostels were opened wef 01 Nov 2021 for SE and TE and wef 15 Nov 2021 for BE. Rooms once allotted should be occupied by the respective students and fee are required to be paid.

5. Refund of messing charges of AY 2020-21 is still pending.

Decision Taken.

- (a) This will be processed on priority. List of students incl their bank account No is required for refund. President, Student Council with the help class reps is reqd to submit the same for further action.
- (b) If student is sure about their refund, they can deduct Rs 5423/- from the current fee and deposit balance fee through ERP. No mistake is acceptable as it will be treated as breach of trust and doubtful integrity. In case of doubts, please deposit full fee and claim refund later on.

6. Wi Fi charges should not be paid by students who have not reported to Hostel.

Decision Taken.

Wi Fi charges will be charged from all students as TATA Communications is not giving any concession to AIT, Pune for the students who has not arrived to hostel due to personal reasons. .

7. Why Hostel and Messing Fees have been charged till Jun 2022?

Decision Taken.

Hostel and Messing Fees have been charged till June 2022, assuming that the academic session will be extended till Jun 2022 due to Covid 19.

8. Why should students pay barber charges, messing charges and laundry charges?

Decision Taken.


Students who have not arrived till date to hostel and rooms are allotted on their names have to pay full hostel fee and wi fi charges. Balance fee like laundry charges, barber charges and messing will be charged as per actuals and applicable rules.

9. A request was made by students to waive off the late fee. It was agreed that payment of hostel fee to be done by 07 Feb 2022 without late fee with one condition. The condition is to pay fine of Rs 5000/- after 07 Feb 2022, if full fee is not paid as applicable. .
