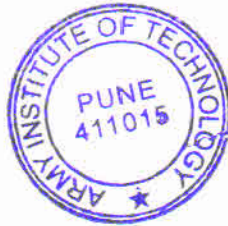
Transfer Procedure:

3. Pay the **processing fee of ₹600/-** through the **online payment gateway**.
4. Only students who complete all the above steps will be considered **eligible for transfer**.

This process is applicable from the **Academic Year 2025-2026** onwards.

Subject: Regarding Online Equivalency of All Academic Courses of Colleges/Institutions under Savitribai Phule Pune University

Reference: Eligibility Section Office letter No. Shaisha/118, dated 28/04/2016

All concerned are hereby informed that the affiliated colleges under Savitribai Phule Pune University are required to carry out the equivalency process of their courses with recognized institutions. This process was earlier conducted in the traditional (offline) manner, which resulted in considerable time consumption for both the affiliated colleges and the recognized institutions.

To avoid such time delays and in view of the instructions issued by the Central Government, State Government, and concerned institutions regarding cashless transactions, the said process will now be conducted online. A computerized system has been developed for this purpose.

The process can be completed through the BOD login of the college/institution on the University website, for which a fee of Rs. 600/- will be charged online.

All Hon'ble Principals/Directors of affiliated colleges and recognized institutions are requested to bring the contents of this circular to the notice of all concerned. A user guide for the online equivalency process is attached herewith.
